

### **SPRING CLEANUP DAY TO BE HELD SATURDAY, APRIL 12**

### ANNUAL BHA EVENT PROMISES TO BE BIGGER AND BETTER THAN EVER - DON'T MISS OUT!

It's official; spring is here, and so is the community's Annual Spring Cleanup Day. The BHA has partnered with the Hillsborough County Board of Commissioners, Sheriff's Department, and UrbanErecycling to provide residents with a one-stop opportunity to get rid of J-U-N-K, yes, junk, for free.

Most of us have unwanted items that has been sitting in our homes, garages, and back yards for months, and even years. Your BHA wants to help you get rid of it. Why take a costly trip to the county landfill when you can dispose of that wreck of a couch, rusted refrigerator, and more right in your own neighborhood?

This year's cleanup will be held Saturday, April 12, 9 a.m.-1 p.m. (or until trash bins are full). As in past years, the collection site is on Natures Way at the Hillsborough County Parks Maintenance Facility near Alafia Elementary School.

### What's new this year?

Popular demand caused the BHA to look for an organization that would take items that typically could not be taken at past cleanup events. Joining forces with the BHA is UrbanErecycling (an organization that recycles material with

our environment in mind), ensuring nothing will end up in landfills. In addition, they will perform data destruction on hard drives to DOD standards free of charge, and provide a certificate of that service to residents via email.

UrbanErecycling will be on location to accept the following items for recycling purposes: computer keyboards, laptops, desktop computers, tower computers and servers, scrap computers, telecom equipment, rack servers, cell phones, laser printers, flat screen monitors and flat screen TVs, battery backups, ion lithium batteries, circuit boards, and computer cables.

The Hillsborough County Sheriff's Office will also be on hand with its popular Operation Medicine Cabinet



There are 143 days until the August 26 primary election. And the Supervisor of Elections (SOE) office is already in full swing preparing for what Supervisor Craig Latimer compares to putting on a Super Bowl. "Except ours has 550,000 invitations, 347 venues, lasts for 2 weeks, requires a trained staff, and must report the outcome in a timely and accurate fashion!"

### PRE-VOTING CHECKLIST

- Ensure all information is up to date (address, phone and signature)

Between now and primary day, the SOE office will increase from 40 full-time staff members to 4,000 full-time and temporary employees. The number one goal of the staff is to make sure voters feel confident in the process. Quality control, quality assurance, counting, and recounting are built into every step of preparation and execution of the election process. And then they will turn around and do it all over again for general election on November 4.

For Bloomingdale voters, this

intense preparation means the staffing of six polling places and, for Early Voting, the Bloomingdale Library. "Always remember, Election Day is not the first day to vote but the last day to vote," commented Supervisor Latimer. Early voting and vote by mail are easy alternatives to voting in person on Election Day.

### Early Voting

While the closest Early Voting location for Bloomingdale is the Bloomingdale Library, this location has been one of the busiest in previous elections. In 2012, it was the second busiest Early Voting place in Hillsborough County with 2,641 voters. To help avoid waiting in line, voters should remember that they can vote at any Early Voting location and their ballot will be printed on demand. Additionally, the SOE website will post wait times at each location during Early Voting, which runs August 14-24, 10 a.m.-6 p.m. for the primary election, and October 23-November 2, 7 a.m.-7 p.m., for the General Election.

### Vote by Mail

The SOE is also heavily promoting Vote by Mail. Voters may request one of these ballots online, by phone, or in person at the SOE offices by 5 p.m. on the sixth day before the election. Return postage is paid by the SOE, and the ballot can be tracked online to reassure voters their ballot has not been lost. Once requested, the voter will automatically receive a Vote by Mail ballot for the following two primary and General Elections. On primary and General Election evenings, these are the first results reported.

Every Vote by Mail ballot has a bar code so that it can be matched to the precinct and voter who requested it, and then verified that as received back at the elections office. Once received, ballots are separated by hand from the return envelope, still in the security sleeve, rendering it a secret ballot. Ballots are counted and recounted to ensure accountability.

#### Voters with Disabilities

Hillsborough County is especially proud of the AutoMark voting machinesprovided for voters with disabilities and allowing them to mark their ballots using an audio function with a headset, a Braille keypad, a zoom-in large-print feature, a sip-and-puff device, or a two-switch pedal device. These are available during both Early Voting and Election Days.

Bloomingdale voters can be proud of the fact that during the 2012 election, each of the six precincts assigned to this community had well over 70 percent voter turnout. Residents are encouraged to visit the SOE website, www.votehillsborough.org, to learn more about registering to vote, Early Voting locations, request a Vote by Mail ballot, and/or verify their precinct or voter registration information.



Privacy partitions (used to create voting booths) are stacked in the SOE warehouse and ready for delivery to the 347 precincts in Hillsborough County.

### **NEW WATERING RESTRICTIONS**

Beginning Saturday, March 1, Hillsborough County residents will have two days a week to water their lawns, instead of one. The new schedule for watering established lawns and landscaping in unincorporated Hillsborough County, as well as the City of Tampa, is:

- Addresses ending in 0, 1, 2 or 3 Mondays and Thursdays
- Addresses ending in 4, 5 or 6 Tuesdays and Fridays
- Addresses ending in 7, 8 or 9 Wednesdays and Saturdays
- Locations with no address (common areas) and locations with mixed addresses (such as office complexes and shopping centers) - Wednesdays and Saturdays

All watering must be done before 8 a.m. or after 6 p.m., and only once on your designated days. For complete information on these and other water rules in unincorporated Hillsborough County visit www. HillsboroughCounty.org/WaterRestrictions.

### CELEBRATING 4TH YEAR ANNIVERSARY AS BLOOMINGDALE CRD

On March 22 I completed my 4th year as your Community Resource Deputy (CRD) for Bloomingdale. Thank you for a very busy, great four years! I look forward to working with all of you in continuing the outstanding work that has been done to make Bloomingdale and the surrounding communities safer and more secure places to live and work.

### Stolen Property - Contact HCSO First

At a recent monthly meeting of the Bloomingdale Area Community Council (BACC), Hillsborough County Sheriff's Office Detective James Howell, District IV Latent Investigations Section, briefed members of the BACC on home and vehicle burglaries that recently occurred in the Bloomingdale area.

Detective Howell emphasized that residents should report any stolen property immediately to the Sheriff's dispatch at 813-247-8200 before posting any news on social media. This action will help deputies and detectives to possibly apprehend the thieves and also improve their investigations and ability to find and have the property returned.

Detective Howell also noted that any person finding lost or abandoned property is required by law, specifically 2013 Florida Statue 705.102, to report the description and location of the property to a law enforcement officer. This officer will determine whether the person reporting the lost property wishes to make a claim to it if the rightful owner cannot be identified or located. Any person who unlawfully appropriates lost or abandoned property for their own use has committed a theft as defined by Florida Statue 812.014 and is subject to punishment.

Please help the Sheriff's Office publicize the upcoming OPERATION MEDICINE CABINET. Copy and share the following information with your family, friends and neighbors! Detective Howell and Deputy Warren also emphasized the importance of residents properly securing valuable items such as weapons or jewelry in safes or other special containers! Our Sheriff's deputies and detectives are working hard to protect the residents of our area, their homes and their property. But it takes a joint effort to continue to reduce crime in our area and arrest those who choose to break the law. Crimes will continue, especially with our economy as it is today. Do your part to help stop crime!

### Stop Illegal Dumping - Dispose of unwanted items at **BHA's upcoming Community Cleanup**

Several cases of illegal dumping have been reported in our community. Anyone even thinking about illegally dumping trash or other items in our area should know that increased alarm monitoring and surveillance has been put in place in several areas. Those caught illegally dumping will be paying heavy fines that can include charges for illegally dumping hazardous waste.

The best way to dispose of unwanted items is to take them to the County's Waste Management facilities or take part in the BHA Community Cleanup Day taking place on April 12 at the Hillsborough County Parks Maintenance Facility on Nature's Way by Alafia Elementary.

### **DINING WITH DAVE**

Restaurants trying to make a go of it at Plaza Bella have been the urchin children of Bloomingdale for far too long. There have been some solid attempts over the years, but the location does not lend itself to easy access. Anyone wanting to dine here and deal with evening traffic had best be committed to the cause. Fortunately, the Shrimp Boat offers a dining experience that is worth the effort.

Having enjoyed great success on Lumsden Road, the new digs offer faithful diners who followed them to our doorstep a larger and more accommodating dining room, updated bar facilities and an overall more grandiose appearance. Even the outside atmosphere while waiting for a table is a bit more conversation friendly and interesting.

Starting with the bar, the beer taps and bottles have a selection of Tampa standards plus a short but solid line up of micros that rotate regularly. The full bar offers a variety of boat drinks to start you up before dinner and coffee / liquors to slow you down afterwards. Like the other bar choices, the wine list is short but thoughtful with enough variety to compliment everything on the menu.

For dinner, I went the surf route while my dining companion opted for turf. The Shrimp Boat does NOT skimp on the shrimp in their Scampi! Good sized and plentiful shrimp, mushrooms and spinach mixed with a lemony touched creamy garlic sauce were served over perfectly cooked angel hair pasta and topped with smooth asiago cheese. The Shrimp Boat offers a good steak as well. The prime rib, light and buttery on the taste buds, was cooked to perfection.



For a side dish we tried the cheddar and bacon grits with chive—a little on the dry side, but served to compliment the saucy scampi. For dessert we took our server's recommendation and had the in-house salted caramel ice cream, which had the texture of sorbet and could, by itself, be a reason to dine here. Live music on the weekends adds a dash of date-night flair to a reasonably priced meal of this quality.

The Bloomingdale Homeowners Association works behind the scenes on many issues brought to us through resident calls and emails. While we are not always able to fix the issues completely, most of the time, we help to make the situation better, usually much better. Recently, the BHA received high praise for our assistance in helping to resolve a community issue in Bloomingdale Estates. The letter below, written by Linda Newcomb, a long-term Bloomingdale Estates resident, is an example of how the BHA, working with residents, can make a difference in our community. Thank you, Linda!



Resident Letter:

County repairs pump station driveway hazard on Bloomingfield Drive

In February, concerned neighbors in the 200 block of Bloomingfield Drive, spearheaded by resident John Hnizdil, talked with Hillsborough County Public Works representatives regarding standing muddy water across the sidewalk of the Bloomingfield County Pump Station. The issue was not only very unsightly, but presented a slip and fall hazard for residents. At that time, it was suggested that a drain could, possibly, be installed to take care of the problem, but according to a County worker that inspected the area, he doubted anything would be done.

Following the communication with County, one of the neighbors contacted the Bloomingdale Homeowners Association via email. Pictures of the area were forwarded with explanation of the frustration the neighbors were experiencing who lived near this site and the BHA's help was requested.

After only a few days, the County came to pressure wash the driveway. This was an improvement visually, but the standing water issue was not resolved. Surprisingly, the following week County workers were out with heavy equipment breaking up most of the driveway, removing huge chunks of concrete and installing a new driveway slanting to properly drain away the rain water.

PROBLEM SOLVED, thanks to concerned neighbors, the County, and especially, the Homeowners Association who greatly supported this effort. On a personal note and as a resident of this area for 24 years, it is vital that homeowners who have invested their lives in their neighborhoods get involved helping to improve and to keep Bloomingdale a nice place to live.

### **BLOOMINGDALE ESTATES DEED RESTRICTION UPDATE NEARS COMPLETION**

Following another meeting with neighborhood leaders and the Bloomingdale Homeowners Association, Bloomingdale Estates residents are one step closer to the final draft update to their neighborhood's outdated deed restrictions. The meeting, held March 25, was a review of all previously recommended amendments before the draft document is forwarded to the BHA attorney for examination.

Like many of the community's neighborhoods, Bloomingdale Estates deed restrictions are over 34 years old and need to be modernized and streamlined. This is the first-ever attempt by residents, with the assistance of the Bloomingdale Homeowners Association, to accomplish this task.

Long-term resident and local realtor, Mary Odum said, "I was involved with the creation of the Bloomingdale Special Taxing District in 1984, and because of this, I recognize the importance of what we [residents] are trying to accomplish here now."

Odum added, "Because we have deed restriction standards, I have always had complete confidence and pride when showing homes [as a realtor] in the Bloomingdale area."

The process is time-consuming and has required patience from all involved. However, progress is being made. Once the latest meeting changes are added to the draft document, copies will be emailed to the core volunteer group for a final once-over. Then, the draft document will be sent to the BHA's attorney for legal review. Best case scenario would be that no additional changes are required, and Bloomingdale Estates resident vote-gathering would begin. program, which prevents potentially dangerous drugs from getting into the wrong hands. Representatives will be available to receive dangerous, outdated, unwanted prescription medicines and drugs. Accepted items include: Pill bottles, Boxes and/or packaged drug items, Patches, Powders, Liquids (properly sealed), Inhalers, and Veterinarian Prescription Drugs.

While the BHA has added these new partners to improve service to residents, the trash roll-offs provided by Hillsborough County still have certain guidelines as to what may be deposited.

Hillsborough County accepted roll-off items include:

- · Refrigerators, ovens, water heaters
- Steel and other metals
- Furniture (such as couches, chairs, tables and mattresses)
- Construction debris (such as concrete, bricks, glass and roofing materials), and tires.

Some Items cannot be accepted by Hillsborough County:

- No televisions, microwaves, computers or radios (UrbanErecycling will take flat screen TVS and computers as noted above.)
- · No yard waste
- No hazardous materials including paint, batteries, propane tanks, household chemicals and waste from commercials activities

### **HOLDING YOUR PUTTER LIKE NO OTHER (CLUB)**

The majority of us hold our putters just like any other club in the bag with the grip underneath the heel pad of our hands, causing the putter to be held at an incorrect angle.

Two things occur: the putter head is toe up, causing the ball not to be hit solid and the path of the putter to be more on an arc than usual (causing misses in both directions).

When the putter grip is held underneath the thumb pad, the putter shaft follows right up the forearm. The putter and arm will act as one unit.





This will allow you to set yours eyes over the ball, have more of a straight back and through putting arc and more center contact on the putter face.

More than 120 Florida YMCA Youth in Government (YIG) high school students from the Tampa area took charge at the 57th Annual Florida State Assembly held February 20-22 in Tallahassee. Most of them were members of the Campo YIG Chapter, the largest chapter in Hillsborough County. Teens had the opportunity to sit in the same chamber seats that senators and representatives use. They experienced the steps necessary to pass and debate laws and also campaigned for different state-wide positions in YIG, including State Governor.

The Assembly acts as the culmination of the YMCA YIG program. The YIG is a year-round civic engagement and service learning experience that offers students around the state the opportunity to participate in a student-run, student-led model government process.

"[YIG] trains nearly 3,000 students state wide on how to be civic-minded citizens. It teaches students how to interact with their government effectively in ways that affect change," explains outgoing YIG State Governor Seth Reid. Reid is a Bloomingdale resident and home-schooled senior, and member of the Campo YIG Chapter. "Students learn the process of law-making, the judicial system, our executive branch, and how lobbyists can affect the government. It's a wonderful program which truly does train leaders for tomorrow—leaders this world needs."

Local chapters like Campo work together on debate practices, servicelearning projects, fundraising efforts, and State Assembly preparation. Students choose an area of focus, and through these personas delegates are given the means to learn about their specific role in the context of state government.

Led by volunteer advisor Patty McClure, the Campo Chapter has grown over the last 6 years to approximately 90 members including both middle school (junior YIG) and high school-aged teens. The chapters are non-partisan, which allows the teens to explore and develop their own political beliefs as well as appreciate those of others. An important skill the teens learn is to debate an issue from both sides, no matter their own opinion.

David Little, also a Bloomingdale senior home schooler, observed, "YIG members are empowered

to form and express opinions on important issues, then debate with their peers in the community and the state without judgement." Some YIG teens hope to run for public office one day; others know they will come away as informed voters.

This year's state assembly proved very successful for the Campo Chapter, with numerous members being elected to state YIG positions as well as receiving Outstanding Statesman, Cabinet Member, and Civil and Criminal Attorney awards. Members Becca Ross, Colin Pearson, and Braxton Mann had bills passed to the Cabinet, and Pearson and Mann's bills were signed by the YIG State Governor.

The YIG program is based on the Y's values of responsibility, respect, caring, honesty, and faith. If interested in learning more about Florida YIG, contact the Campo Family YMCA at 813-684-1371.

On any given night and any Saturday afternoon you are surely to find something going on.






