WAWA GRAND OPENS WITH FANFARE AND FREE COFFEE FOR ALL By: Miriam Leech

The much-anticipated Valrico Wawa held its grand opening on July 10. Wawa representatives were joined by local officials and members of the community for the fanfare-filled celebration. The grand opening of the Valrico store marks the chain's 11th store to open in Florida in 2014, and the 44th overall.

On hand for the ceremonial ribbon-cutting were Wawa Senior Vice President Cathy Pulos, Director of Store Operations Todd Souders, Area Manager Peter Rasmussen, General Manager Kira Faust, Wawa associates, customers and, of course, Wawa's mascot, Wally Goose.

Representatives from the United Service Organization (USO) Tampa Bay were presented with a check on behalf of the Wawa Foundation for \$4,334. The funds were raised across the state of Florida between June 14 and July 6 as a part of the Summer UPC campaign, where customers are invited to donate \$1, \$3, or \$5 as a part of their purchase.

Local residents turned out in full force to welcome the new store and were treated to free coffee and storewide discounts. A group of eight high schoolers even camped out over night to be the first customers in the store

Living by a pond can provide years of enjoyment by creating opportunities for bird watching, fishing, photography and sunset gazing. While many people enjoy the benefits of living close to a pond, others wonder what they can do to promote a healthier pond environment.

With the help of the Hillsborough County Public Works Department Adopt-A-Pond program, you can play an active role in maintaining or improving your pond's water quality and overall health. The Adopt-A-Pond program collaborates with communities to teach residents how to improve the water quality, wildlife habitat and appearance of storm water ponds. The program's pond specialists also guide participants through the initial steps of how to care for their storm water ponds to provide enjoyment for years to come.

Since 1991, Hillsborough County Public Works Department staff has worked with over 300 pond groups to empower them with the skills and knowledge to make good pond maintenance decisions. We have successfully helped tackle issues with invasive plants, trash, algae, duckweed, lack of native plants and erosion—you name it, we have done it. We have collaborated with neighborhood groups throughout the county and we are looking forward to a chance to work with the Bloomingdale community as well.

If you would like to improve a pond in your neighborhood, here is all you need to get started:

- An Enthusiastic Group Find a team willing to get in the water to clean up, plant, maintain and monitor the pond. Adopting a pond is too much of a job for one person. Get your neighbors together and have fun with it!
- A Group Representative Enlist a leader to organize the project and communicate with the group and the County's Adopt-A-Pond coordinator.
- Time Pond transformations do not take place overnight. It takes months, and maybe years, to see the full effects of the change. That is why the Adopt-A-Pond process is a three-year agreement.

If you are ready to make a change in your pond, visit www.HillsboroughCounty.org/AdoptAPond to find out more about the program and complete an application. There are no fees to participate. Simply apply today to see if your pond qualifies.

when the doors opened at 8 a.m. "We wanted bragging rights," said Bloomingdale student Katia Zavala. "[Wawa employees] gave us donuts and hot chocolate around 6:30 a.m.!"

General Manager Kira Faust lives locally, just down the road in FishHawk, and will lead a team of nearly 60 associates--all of whom are taking new positions created in the area through the development of the store. Her store is also the first to offer Florida Lottery tickets.

Ordering a famous Wawa built-to-order hoagie or specialty beverage is made easy by touch pad displays that allow patrons to customize their food and drinks. The store also offers their award-winning coffee (195 million cups sold annually); hot breakfast sandwich, the Sizzli; bakery items; and a Wawa line of dairy products, juices, and teas.

The grand opening event concluded with Hoagies for Heroes, a charitable hoagie building competition with members of the Tampa Bay Chapter of the USO sporting their sandwich-making skills. The competition concluded with a \$1,000 check presentation to the winning and runner up USO Tampa Bay teams.

ARRESTS MADE IN SANDY CREEK VEHICLE BREAK-INS, RESIDENTS PRAISED

Arrested...this is the word that applies to the suspects involved in the recent Sandy Creek-area vehicle burglaries, and Bloomingdale Little League attempted burglary that occurred on June 25. According to Hillsborough County Sheriff's Office Master Deputy Curtis Warren at the Bloomingdale Area Community Council Meeting on July 24, four teenagers were apprehended and charged with 10 counts of vehicle burglary, one count of armed vehicle burglary (a loaded weapon was stolen), and one count of attempted burglary of a structure.

Residents of the Bloomingdale community played an important part in the positive outcome of this case. Once the burglaries were discovered and reported, law enforcement officials received home security camera footage from several Sandy Creek homeowners. In addition, the Bloomingdale Homeowners Association posted a resident-provided video still of one of the suspects "in the act" on the Association's Facebook page and community website. That post went "community viral" with over 10,000 views and 135 shares.

Lead investigator Detective James Howell called resident help "crucial" to solving what are normally difficult cases. "I received more video coverage (on this case) than I have ever received," said Howell. "The videos provided a critical piece to our investigation."

With the Sandy Creek footage, he was able to link the suspects with another burglary attempt at the Bloomingdale Little League concessions building. Management of the facility supplied security footage as well, and connections were made which linked the incidents to the same individuals.

The teenagers were engaged in what Howell termed "car hopping." He explained that groups, usually late teens and adults, will work together between the hours of 12:30 a.m. and 5 a.m. pulling door handles on any vehicles parked on the street or driveways. With car hopping, groups will not normally use force to gain access. However, should a door

be unsecured, the group will quickly look for anything valuable to steal. Video footage showed the burglaries, from start to finish, occurring in a matter of seconds.

In the Sandy Creek cases, the most significant item stolen was a loaded weapon, which carries a felony charge. With the arrests, the weapon has been recovered, but Howell stressed that gun owners need to write down serial numbers and keep the information with other important documents.

Some crimes are preventable, or can at least be made more difficult to perpetrate. Howell advised: lock car doors, keep any valuables in cars out of view, keep garage doors down (even if you are home), and be observant. "It is all about opportunity, and you just can't create an opportunity for these guys (potential thieves)."

Master Deputy Warren echoed Howell's statements, "You know who belongs in your neighborhood and who doesn't. Write down license plate numbers and descriptions of vehicles and people. If it is potential evidence, report it." If you have information pertaining to a crime, contact the Hillsborough County Dispatch Line at 247-8000.

RACE HEATS UP FOR DISTRICT 4 BOARD OF COUNTY COMMISSIONERS

The August 26 Primary Election is upon us. Since Primary results determine who will be on the November 4 General Election ballot, candidates are turning up the heat on their campaigns during the last few weeks. Now is the time to consider the candidates for the District 4 Board of County Commissioners' race: Janet Dougherty, Rick Cochran, Stacy White, and write-in candidate Christopher Weaver. They are running to fill the seat left vacant by Commissioner Al Higginbotham, who is running for the District 7 county-wide seat.

While Weaver is a write-in, Dougherty, Cochran, and White are all Republican candidates; this makes the District 4 race noteworthy. Florida is a closed primary state; however, a 1998 constitutional amendment opened primaries to all voters in races in which all the candidates come from the same party, in essence making the primary a general election. But, there is a loophole: when there is a write-in candidate on the ballot, the primary again is closed because write-ins are treated as a candidate from another party.

With a closed primary, the district's 75,000 registered Republicans will choose their candidate on August 26, and in November the 65,000 Democrats and 54,000 other voters will decide between winner of the primary or writing in Weaver's name. (Note: Write-in candidate Christopher Weaver did not respond to e-mails or phone messages despite repeated attempts to request an interview.)

There are seven members of the Board of County Commissioners. Four are elected from single-member districts, and three are elected county-wide (Source: Hillsborough County Government). What do County Commissioners actually do?

- Develop policy for the management of Hillsborough County
- Provide direction to the County Administrator on any programs for the improvement of the county and the welfare of its residents
- Approve the county's operating and capital budgets, and the county's capital improvement program
- Serve as the Environmental Protection Commission
- Individual Commissioners serve on various other boards, authorities, and commissions

DISTRICT 4 SCHOOL BOARD CANDIDATES

Janet Dougherty

What made you decide to run for the Hillsborough Board of County Commissioners?

How do you feel about the decisions that led to the Bloomingdale Big Box Development, and what will you do to either curtail this kind of development or make certain it never happens again? And how do you view the residents' voice in community development?

A lot of County employees live in our Bloomingdale neighborhoods, and many have gone a long time without adequate/ appropriate raises but have seen their cost of living go up. What will you do to help these constituents?

Are you familiar with the traffic issues affecting the Bloomingdale area (Bloomingdale Avenue, Lithia-Pinecrest Road, Bell Shoals Road), and what will you do to affect them?

How will you communicate with Bloomingdale residents?

In a field of Republican candidates, how do you set yourself apart?

Dougherty shared that she was encouraged by friends and family to run for the BOCC because they felt she could make a real contribution. She has served her community for 30 years. "I love my community. But it is not about me, it is about the people. My favorite part of campaigning is knocking on doors and getting input from the people."

Dougherty believes there was a lack of transparency, and that perhaps there were protocol issues at the end of the Big Box Development process. Dougherty had hoped to propose a onetime solution to turn the property into park land. She would like to see the community become proactive in planning for undeveloped property so that they are empowered to go to the County with plans instead of vice versa. She sees an important role for homeowners' associations in that process. Additionally, Dougherty said, "We need to incentivize development of old property where buildings are sitting vacant."

Dougherty shared that the BOCC has a \$3.38 billion budget. She has promised to work to shape the community to thrive economically by streamlining government and enacting checks and balances to eliminate wasteful spending. "We have to find money in the county coffers to help give livable wages to our county employees."

Dougherty shared that she has personally experienced the traffic delays on Bloomingdale roads, and sees Bloomingdale as having some of the worst traffic in the County. She stated that she will do anything and everything she can to address the traffic issues. "Traffic is job number one for the BOCC. It will not be easy, but we can't just think our way out of this issue."

Dougherty explained that, if elected, she hopes to attend Bloomingdale Homeowners' Association meetings as well as communicate with residents through the Bloomingdale Gazette. She hopes the CAN-DO group will stay active to help build public-private partnerships for the Bloomingdale area. "I am totally committed to holding town hall meetings in my district [including Bloomingdale] AFTER HOURS for working people to attend."

Dougherty explained that she has been the most involved Republican of the candidates—since the age of 22—and has helped over 50 candidates get elected during that time. She reiterated that she has 30 years of volunteer experience involving issues that come before the BOCC, including land-water issues and community-based planning. She has public- and private-sector experience. However, Dougherty stressed that "Everyone is looking for solutions. And potholes aren't partisan."

Rick Cochran

Cochran explained that he has spent his entire adult life serving. After retiring from the Tampa Police Department he was not ready to be "retired," so the board vacancy lined up perfectly with his availability. "I have always been a watcher of politics, and enjoy working with local community members to solve local issues."

Cochran believes the Board of County Commissioners needed to reach out to the people of the Bloomingdale community early on so they could have had their say in the Big Box Development process, and that it should have never moved forward the way that it did. He is against just putting up signs [public notice] as the sole way of communicating with constituents on development issues. "

"The Board of County Commissioners must make sure it is in touch with the public."

Cochran explained that County employees must make fair wages or good employees will be lost. He will advocate for such wages. "Turnover [of employees] costs more than increasing wages in the long run because you lose experience and have to train new workers."

Cochran stated simply that the Bloomingdale-area roads are failing. Now that the economy is better, his goal, if elected, would be to get transportation projects fully funded by the Board of County Commissioners. "Failing roads must be taken off the Board of County Commissioners to-do list."

Cochran explained that as a police officer he learned that problems can't be solved without talking to people in the community. If elected, he can dedicate 100 percent of his time to being a County Commissioner. He would meet with the Bloomingdale Homeowners' Association, and actually listen and apply what he learns from the residents. "I am going to make sure I am available to the people."

Cochran pointed out that he has proven leadership skills from his experience in the Air Force and his 25 years as a Tampa police officer. He explained that the decisiveness he learned as a police officer gives him a huge advantage, and that he is experienced in applying laws and talking to stakeholders. But mostly, he cites his time and ability to be dedicated to his job. "One hundred percent of my time will be given back to the people who put me in office."

Stacy White

White shared that he has always been called to serve his community. Knowing that the Board of County Commissioners affects his community in so many ways made the run the next logical step after serving on the School Board. "I felt called to step up to the plate and fill the vacancy on the board."

White says that, at best, there was not enough outreach to the community in the Big Box Development process, and that the Board of County Commissioners must do more than put up a yellow sign [public notice] to communicate with its constituents on development issues. He commits to do his homework on development issues, attend homeowners' association meetings, and reach out to his Bloomingdale contacts to do a better job of public involvement. "I stand with the people."

White explained that he has a proven record of pushing for increases in wages—as a member of the School Board he has advocated for school employees.

"I have no issue spending money where it is important, and that is on our front-line folks [employees].

White explained that, as a resident of the Bloomingdale area, he is very familiar with the traffic issues. He is very concerned about the increased impacts on the roads caused by the Big Box Development and the new Wawa at the corner of Bloomingdale Ave. and Lithia-Pinecrest Rd. He stated that he would work with Bloomingdale residents to form an informal committee on traffic issues. "I would like to work to look at the big picture of maintaining traffic as well as the character of the area."

White said that he would communicate with Bloomingdale residents by holding town hall meetings, via e-mail, and by attending Bloomingdale Homeowners' Association meetings. "Attending HOA meetings is an outstanding method to reach key leaders and grass roots constituents."

White emphasized that he is the only candidate who has a proven record in office [as a School Board member]. He pointed out that the School Board functions much like the Board of County Commissioners in that both bodies set policy and make hiring decisions—so he brings that experience with him. "I have walked in those shoes [Board member] to motivate, work with staff, and use resources, and I have stood with my people in the community."

NEW SPACE, NEW FACE

AT BLOOMINGDALE REGIONAL PUBLIC LIBRARY

With 10,000 square feet of new space, and a brand new library manager, the Bloomingdale Regional Public Library has even more to offer the community. The 2.1 million dollar expansion was unveiled on May 23, and Vickie Ricketts took over as manager on June 16.

The expansion features an enlarged children's room, a second community room that seats 130 people, an Innovation Studio that includes six computers with creative software, a vending café, a new reading room with collaborative technology and trendy furniture, and an enhanced bookstore operated by the Friends of the Bloomingdale Regional Public Library.

Of particular note is the glass artwork of local, award-winning artist Lisa Vogt. Her work, entitled Dreams Come True, graces the new children's room and features the White Rabbit from Alice in Wonderland, a sailing ship, butterflies, and more. Vogt makes her home in Wesley Chapel.

The library is also using its expanded space to showcase local startup businesses. The library has partnered with a local nonprofit, SiliconGlades, to host entrepreneurs

It is now the second busiest branch in Hillsborough County.

Ricketts wants to remind Bloomingdale residents that, "...this is part of your community, and we are here to meet your needs."

BoRyals's cowspolitely stepped aside up the cow.' when, in 1979, Criterion began developing the land now known as Bloomingdale East. The Ryals still live on Culbreath on a few acres that remain from their vast dairyland which stretched from Bell Shoals to Culbreath and down to the Alafia.

"The agreement was for Criterion to keep moving the fence back as they developed neighborhoods," recalled Fred Uphoff, quite literally the fifth resident to move into Bloomingdale East.

In the past few years the Bloomingdale area has seen a rapid increase in the number of fast-casual restaurant chains serving ethnic-based dining options. In the good ol' days, such establishments were simply known as "that place down the street" or a "good cheap joint." They are family owned and operated, one-of-a-kind storefronts with a front counter, a few tables scattered about, and a cooler full of drink options. Tucked away in a small retail strip next to a charter school on Boyette Road (near the Bell Shoals Road intersection), La Villa Mexican Grill offers authentic south of the border entrees in a setting that is more casual than fast ... but mighty tasty!

For a sit down meal, I recommend starting with one of the homemade soups. The tortilla soup made with hominy, cheese, cilantro, sour cream, and avocado is served with corn chips, while the tomato soup is creamy and filling with roasted corn. Monday thru Friday they offer a reasonably priced dinner plate combining traditional homemade dishes (beef, chicken, or pork) and enough sides to make it a true meal. Try the tacos (both meat and fish) either as an appetizer or a main course alongside quesadillas or enchiladas with a heaping helping of excellent guacamole. There must be a secret ingredient, but knowing what it is might ruin the thrill of the taste. Their tamales are the best I have had in and around the Tampa area. Desserts are limited, but there is little reason to order anything other than the home made flan.

For lunch, stop by for a burrito to go, a stack of tamales or a sack of tacos. Ask for it spicy as they tend to downplay this for most customers. Like dinner, a combo plate is available on week days and comes with fresh fried plantains. Your office mates will be truly jealous. Drinks are limited to juices and soft drinks from the cooler, but the selection is quite a treat as it includes soft drinks from across Mexico to give your taste buds a treat.

One of my favorite aspects of La Villa Mexican Grill is that not everything on the menu is available every day and more often than not there is an unusually tasty special that is gobbled up almost as soon as it is available. Like a truly authentic family run restaurant, fresh is the key to every meal and that means items run out on occasion. When that happens all you can do is grin and dive in to something new.

SECOND BLOOMINGDALE ROUNDTABLE MEETING HELD

CAN-DO PROVIDES STATUS

The Bloomingdale Roundtable, a group of community leaders from the Bloomingdale Homeowners Association (BHA) and neighborhood mandatory homeowners associations, met July 23 at the Bloomingdale Community Office. The group formed for the first time in March 2014 to develop a community leader network aimed at bettering Bloomingdale now and in the future.

Attendees included representatives from Bloomingdale Ridge (Fox Run and The Greens), Bloomingdale Cove, Cambridge Cove, River Crossing, Bristol Green, Somerset (via email), Mason Oaks (a neighboring community off Lithia-Pinecrest), Can-Do and the BHA. Twelve leaders attended the quarterly meeting representing over 1,100 homeowners.

CAN-DO UPDATE

Fred Brown of Can-Do was the roundtable's featured guest speaker this quarter. He provided the group with the current status of his organization's completed legal action and mediation with Red Cast Developers and Hillsborough County regarding the "Big Box" development on Bloomingdale Ave. He also shared that because a settlement has been reached, he and his organization can no longer be a part of any future legal actions.

"We did not get what we wanted," said Brown, "but some concessions were made." When several expressed concerns about who will ensure that the mediation document is adhered to, Brown stated, "Can-Do will not dissolve until all mediation pieces are met."

Further, he explained that the completed action does not preclude other individuals, groups, or HOAs from continuing to pursue actions against the proposed deployment. To that end, his group is willing to pass historical and research documents to any interested parties.

Finally, Brown will be providing a letter template to the Roundtable should the leaders, singularly or together, wish to begin a "grass roots" letter writing campaign.

Other Notes

- Bloomingdale Ridge President Terry Hoos briefed the group on an idea regarding benches at neighborhood entryways for school children waiting for the bus. He will explore the idea, and provide information to the Roundtable at a later date.
- BHA Board Member Mary Galin provided an overview of this year's BHA Fall Festival. She offered mandatory HOAs the opportunity to participate either by hosting or sponsoring an activity.
- BHA president George May reminded leaders that the FY 2015 Hillsborough County Mini-Grant Program deadline is Aug.8. This program can provide up to \$2,500 to neighborhoods for projects, functions and improvements.

May concluded the meeting urging attendees to spread the word about upcoming elections. "The County Commissioner election is important; we need to elect someone who represents the heart and soul of our communities."

OAKCREST RESIDENTS ADOPT THEIR POND

On July 21, Oakcrest residents attended an Adopt-A-Pond kick-off meeting conducted by Hillsborough County Adopt-A-Pond Program Coordinator Jennifer Aragon at the Bloomingdale Community Office. Property owners surrounding Pond 14-07, which borders many homes on Wrencrest, Quail Briar, and Moreland Drives, applied for the inclusion of the pond in the program, and the pond was accepted last month. At nearly five acres, the pond is one of the community's largest.

During the meeting, Aragon, an environmental scientist, provided residents with recent inspection results (for which the pond received a "Fair" rating). Key issues included trash accumulations and an overgrowth of invasive vegetation, water hyacinth. She noted that the pond is nearly completely covered by the plant.

Based on her inspection, she presented a phased management plan to help residents coordinate their pond improvement efforts. Calling residents the "eyes of the pond," she stressed the resident involvement and effort needed to improve the pond.

Program staff will work with closely with residents for the next three years in the phased clean-up, planting, and maintaining system.

Taking the lead for Oakcrest pond residents was Roberta Stone, who spearheaded the pond application for the program. A long-time resident, Stone had attempted to maintain the pond area around her home. The task, simply, became too much for her this year.

All attendees, while enthusiastic, expressed concerns about the pond's future, and the impact its current condition has on their enjoyment of the pond and property values.

Aragon concluded the meeting cautioning residents that while Adopt-A-Pond staffers are there to help and guide residents, ultimately residents will determine whether the program will succeed. (See page 7 for details on Adot-A-Pond.)

SCHOOL STARTS THIS MONTH - OBEY THE LAWS!

School starts back this month with the students' first day back on August 19. As parents get ready for this date we ask that they adjust their driving schedules to prepare for the increased traffic. Following are some very important rules that must be followed to keep our kids safe:

- 1. Drivers must stop both ways for school buses making stops for children on roads without median dividers. Example: Bloomingdale Ave.
- 2. Drivers must not speed in school zones. Speeding in school zones is very dangerous and very expensive! Speeding fines are DOUBLED in school zones.

PRIMARY SEAT BELT LAW NOW IN AFFECT

An important reminder, especially for new drivers, is that the primary seat belt law is in full affect. In fact it has affected several drivers' budgets already. Numerous citations have been issued in the amount of \$103—that's money that could have been spent on groceries or bills, rather than a citation and increased insurance rates. All it takes is simply buckling up your seat belt.

PROTECTING OUR YOUNG KIDS

You may have heard the tragic news of a young child who died after being left in a hot car in Georgia. Unfortunately, this wasn't an isolated incident. There is absolutely no excuse for this happening. Anyone with a child in their car is totally responsible for that child's safety.

Here are two ways to prevent this type of incident:

- Place a needed item such as a laptop, briefcase, coat or purse in the back seat as a reminder that you have a very precious child in the back seat, too.
- Keep an eye out when you are in busy parking lots for children or pets left in cars and call 911 immediately if you spot something concerning.

NEW LAWS IN FLORIDA

In our busy day-to-day lives we probably don't give much thought to what's happening in Tallahassee and to the lawmakers we elected and the laws they passed. Well, just this past July, 159 new laws went into effect. Here is a sampling illustrating the wide array of topics addressed: child protection, dangerous sex offender, veteran's support, motor vehicle taxes, education, Medicaid, bicycle ways, flood insurance, cannabis and computer crimes.

It's that time of year again when thoughts turn to what our students need for going back to school. However, we get caught up in the clothes and school supply shopping we forget about a very important part of starting or returning to school... vaccines.

Students starting Kindergarten for the 2014-2015 school year are required to have:

- 4 doses of DTP/Dtap
- 3 doses of Polio
- 1 dose of MMR
- Hib series of 4 doses or 1 after 15 months

3 doses of Hepatitis B

- 1 dose of Varicella (chicken pox) or verification of the disease
- *1 Pneumococcal Conjugate (this is new for this year)

Students starting the 7th grade for the 2014-2015 school year are required to have:

- 5 doses of DTap
- 4 doses of Polio
- 2 doses of MMR
- 3 doses of Hepatitis B
- 1 dose of Varicella (chicken pox) or verification of the disease
- *1 dose of Tdap

It is also recommended, but not required, to be vaccinated for Hepatitis A.

BLOOMINGDALE WELCOMES NEW HEAD FOOTBALL COACH, BRIAN SURCY

The Bloomingdale football program was dealt a blow this spring when Head Coach John Booth accepted the head coaching position at Manatee High School. But, it didn't take long for Principal Sue Burkett and Athletic Director Donnie Peak to find a replacement. After interviews with numerous qualified candidates, Bloomingdale's own running back coach of two years, Brian Surcy, was the natural choice.

Coach Surcy is no stranger to Bloomingdale High and the community. His family moved to Bloomingdale East when he was 7 years old and Surcy later attended Burns Jr. High School as an 8th and 9th grader. As a young boy, Surcy remembers attending high school football games at Brandon High School before Bloomingdale was built. He remembers thinking, "one day that will be me playing football for Bloomingdale High School"—a thought that became reality. Surcy (a 1996 BSHS grad) played running back for Bloomingdale High before going on to play the same position at USF. Surcy shared that he feels extremely excited for the opportunity to lead the BSHS football program. "Red and black colors are in my heart. I've walked these hallways, ate in this lunchroom, sat in these classrooms and gave everything I had on this home field."

As a new head football coach, Surcy is thankful for his staff and their support. This is especially true of Assistant Head Coach/Defensive Coordinator Kevin (Bubba) Steinestel. Steinestel and Surcy played together at Bloomingdale High. Coach Bubba has known Surcy for 20 years and says his passion for Bloomingdale football has never wavered. "He will do anything in his power to get our program to the next level," said Steinestel. "All of his extensive experience, as both a player and coach, has prepared him for his new role as head coach."

Surcy graduated from USF where he ran track and played football, graduating with a bachelor's degree in communications. "USF football was where I actually learned about the game." Throughout college he also continued to feel connected to BSHS. "USF at the time didn't have a band," explained Surcy. When the coach told the team that a high school band would be playing at the first game, Surcy was blown away when he saw the mighty Bloomingdale Bulls Marching Band take the field. "I had the best of both worlds!" Surcy originally interned with ABC news for sports broadcasting but decided not to pursue that career. "I became interested in teaching and coaching in 2003. I absolutely fell in love with it and I hoped that with hard work I would work my way through the coaching ranks."

Hard work is certainly ahead for Surcy. According to Steinestel, learning on the fly and gaining confidence with each game will be a big part of the Bulls season. This is because the team is bringing in an entirely new offensive staff with not much time. "The kids have all been working extremely hard this summer, even with the coaching changes the kids never stopped working," commented Steinestel. Senior offensive tackle Tarron Hampton echoed, "we are putting in lots of work and are preforming better as a team. The loss of our head coach in the spring didn't have an impact on us as a team at all."

A goal among coaches and players alike is to get the community excited about Bloomingdale football. One way to do that according to senior and defensive tackle Tyler Clark is to "win games and become the District champs." Because community involvement is a priority with Surcy, he carries the message outside of Charley Harris Stadium, going door to door introducing himself to local businesses assuring them that the football program can only get better.

"We are excited to see what Coach Surcy brings to the team and to see how the team does this year," commented Tarick Barnes, senior safety. Coach Surcy has a lot of work ahead, but if enthusiasm and experience are good predictors, he and his staff will put Bloomingdale football back on the map.
