NEW SHOPPING CENTER AT THE CORNER OF BLOOMINGDALE AVENUE AND BELL SHOALS ROAD

Community Shopping Centers, Inc. ., of Maitland, Florida, is finally going to be starting that new shopping center at the southwest corner of Bloomingdale Ave. and Bell Shoals Rd.

On May 24, 1985, the County Commission voted 5 to 0 to allow the shopping center construction to begin this year. Community Shopping Centers, Inc. is hopeful that the construction will commence in July or August of 1985 and that construction will be completed and the center ready for opening in March or April 1986. The architect for this shopping center is Mudano Associates of Clearwater. The center will be approximately 230,000 square feet with a Wal-Mart store of 65,000 square feet Wal-Mart has now being the largest of the anchor stores. opened 25-30 stores in Florida within the last year. a tremendous retailer offering a wide variety of general merchadise. Publix Supermarkets will have a 40,00 square foot full-line grocery store with a delicatessen, bakery, and other assorted speciality departments. In addition, there will be a Beall's Department Store of 30,000 square feet and Eckerd Drugstore of 10,000 square feet. There will be approximately 40 service-oriented shops and restaurants.







On May 23, 1985, Susan L. DeLuca was approached via the telephone by Mr. Ted Brown, attorney for Community Shopping Centers, Inc. He requested that the Bloomingdals Homeowner's Association Board of Directors have an emergency meeting regarding the County Commission meeting on May 24 at 9:30 as. This was the reason: Originally an office park complex was scheduled to be built at the southeast corner of Blockingdale Avenue and Bell Shoals Road in the year starting 1985. The Shopping Center, across the street in back of TECO's substation was scheduled to be built beginning in the year 1990. The developers, planners, attorneys, etc. got together and all agreed that the need right now is the shopping center and that the office complex could confortably wait until the 1990's. The problem was that the County Commission had to approve the date swap. Enter Ted Brown and the BHA. It seems that the County Commissioners would not approve the vote one way or the other without some sort of say from the community, even if it was just from a small group of individuals which the Board represented.

Mr. Brown asked that the Board of Directors only and NOT the residents on a whole be polled as to whether or not they oppose this date swap. The Directors in making this decision (which by the way was accomplished in less than five hours) felt they needed more information before giving a letter to this attorney. They obtained site maps, copy of the proposed resolution, available neighborhood feedback and had a telephone discussion with the new Commissioner, Jim Selvey. After all of this was accomplished, they then polled the Board (by telephone) and found the majority in favor of the his proposal. The following is the text of the letter that was given to Mr. Ted Brown for the Commission meeting on May 24, 1985:

Board of County Commissioners Hillsborough County, Fl.

Dear Ladies and Sentlemen:

Pursuant to a request from Nr. Ted Brown, Attorney for the Developer, an emergency session of the Board of Directors of the Bloomingdale Homeowners Association was called to determine the acceptability of the proposed resolution before the County Commission.

After reviewing the site plans and resoultion at Mr. Brown's request, the majority of the Directors of the Bloomingdale Homeowner's Association agree that the shopping center proposal would not present an adverse impact and may, in fact, be of benefit.

Due to the short notice, we are unable to determine the specific opinions of all of the Blockingdale residents.

DON'T LET THEM TAX AWAY YOUR INSURANCE BENEFITS

There is a proposal in Washington to tax health insurance, life insurance, and pension and retirement savings plans that are offered as benefits by employers. This tax, on group life and health insurance, alone, could cost a typical 35-year-old married worker \$27,100 in new taxes over his working lifetime.

This proposal would result in less take-home pay for employees and would cause employers to freeze or reduce employee insurance benefits. The result would be reduced protection for millions of American families.

The government would also tax the increase in the value of individual life insurance policies. This would be like and income tax on the increase in the value of your house, even though you haven't sold it. In both cases, you have no cash income because of the increase in value. That income tax for an average person - one 35 years of age who has just purchased a \$40,000 policy - could amount to \$5,800 over his or her lifetime.

In addition they are also proposing that you should be required to pay an "income" tax if you take out a loan on your policy. They would do this even though a loan is not income; it is a loan, on which you already have to pay interest. And under the proposal, even the interest may not be deductible.

As a taxpaying citizen, I am adamantly opposed to the various proposals to tax my life insurance policies and also the employee benefits, such as life and health insurance, provided by my employer.

If such taxes were enacted this could cost a typical working family an additional \$32,900 in income taxes over their lifetime. I believe these taxes penalize millions of Americans who are seeking to protect their family's future financial security.

I respectfully request that you work against any such proposed tax legislation. DON'T TAX AWAY MY INSURANCE BENEFITS.

I would like to have your views on these issues which are so important to me.






