## STD TRUSTEE NOMINATIONS NOW OPEN TO ALL HOMEOWNERS

On Thursday, October 31, the County informed us that five proposed STD Trustees will have to present resumes at the November 20 County Commission meeting. Therefore, those individuals who wish to be considered for the first-year Board of Trustees for the Bloomingdale Special Taxing District should note the following:

A type-written resume, suitable to be presented to the County Commissioners, should be brought to my home (Susan L. DeLuca, 3906 Kristin Place) no later than Wednesday, November 13.

On Thursday, November 14, at 7:30 p.m., the STD Committee will meet to screen a possible five candidates plus alternates. (Among other things the committee will be screening for is an equal division of representation throughout the entire Bloomingdale area.)

These five people will then be presented at the BHA meeting on November 19 for the approval of the residents of Bloomingdale. If you want to have a say in the first-year Trustees, make your opinions known at this meeting on the 19th.

Then, on Wednesday, November 20, the verified petitions, the draft of the ordinance, and these resumes will be presented at the County Commission meeting to complete another phase of the placement of our STD. This particular meeting is not a Public Hearing--that will take place on December 4.

MOBILE WATCH MONTHLY RECAP

The following is a summary of recorded events for the past month:

- ...Problems in Park West (6 reports; Sheriff notified and responded in two instances.)
- ...Cars parked in a suspicious manner. Plate number recorded. (6 reports)
- ...A car rolled out of a driveway onto the road. Resident informed.
- ...Sheriff's Department called (3 instances). In one case action was taken against offenders. The others are being investigated.

The past month has presented us with numerous problems in Park West. There have been reports of a man with a knife, rope, and sometimes a ski mask, threatening kids in the park. The Sheriff's Department was notified and is keeping a watchful eye on the area. Our mobile units are also paying more attention to activities there. Until we find out the particulars on this individual, or he is apprehended, I caution each of you to keep your children out of the park once it gets dark.

We have also had problems in Park West with gatherings of our young adults at night. In one instance, 11 teenagers were gathered, drinking beer, and causing a disturbance. The Sheriff responded and took the names of 9 teens. The Sheriff also ordered the teens to clean up the area where they were parked (beer cans were scattered all over). While

I realize that our teenagers are young adults and need things to do, I encourage the parents to suggest more productive activities than sitting around the park drinking beer.

The Mobile Watch received five contributions from our residents. I thank each of you for your generosity! We also had three new volunteers. Together we can all make our community a safer place to live.

## MEET THE CANDIDATES FOR THE BHA BOARD

November 1st each year signals the annual elections for half of our Board of Directors of the Bloomingdale Homeowners Association. In compliance with the established Bylaws, the nominating committee presents these individuals who have been nominated by the residents of Bloomingdale and who qualify for the November 19 election. To vote you must be a member of the BHA and have paid your dues as of January 1, 1985. Ballots will be available beginning at 7:30 p.m., November 19, at the Bloomingdale Community Church.

In this election, nine people have been nominated to fill seven positions on the BHA Board. Each of these individuals have agreed to run for this position because they care about Bloomingdale and they want to help it continue to be a great place to live. Following is a brief synopsis of each individual to help you become acquainted with them.

### GEORGE BALL

George Ball has been in the Air Force for 14 years and has been a homeowner three times. He believes that the military members of the community have a special committment in keeping the home values up and making sure the quality of life remains good. George brings an open mind and a varied background to us. Along with his professional background he has been involved in both the Boy Scouts and the Girl Scouts and as military liaison to the March of Dimes. He sees the BHA as a potential political hammer to get improvements in the community.

### BOB HERMIDA

Bob Hermida has lived in the Bloomingdale community for a number of years. He feels the new \$5 BHA dues will get more people involved in the community for the first time as it has with him. 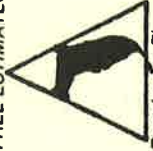
