Proposed school boundary changes

BHA supports changes for Bloomingdale West students

By Ted Grable, BHA President

n Monday, October 4, Hillsborough County School District officials held a public hearing to discuss the most recent of proposed school boundary changes. The boundary changes are facilitated by the anticipated summer 2000 opening of FishHawk Elementary School and FishHawk Middle School, and are also designed to relieve overcrowding at Burns Middle School*, Rodgers Middle School, Lithia Springs Elementary and Boyette Springs Elementary. The Bloomingdale Homeowners Association recognizes the positive impact the proposed boundary changes would provide our students, and strongly supports the changes.

Under the proposed boundary changes, middle school students in Bloomingdale West (currently attending Lithia Springs Elementary, Rodgers Middle School and Bloomingdale High School) would attend Burns Middle School along with their Bloomingdale East neighbors. Bloomingdale West students would continue to attend Lithia Springs Elementary and Bloomingdale High School.

Many Bloomingdale residents are pleased with the prospect of having their children re-join the original Bloomingdale Cluster. However, some residents of the Buckhorn area oppose the changes. The new boundaries would transfer Buckhorn middle school students (currently attending Burns Middle School) to the new FishHawk Middle School.

How Much Taxable Profit?

QUESTION: If I sell my home for a profit, how do I figure the cost basis so that I'll know how much profit tax will be owed?

ANSWER: The difference between the cost and the selling price is taxable at the capital gains rate. The important cost basis is the sum of the original cost plus the dollar value of improvements and selling expenses: You should be able to substantlate these costs in the event of an IRS examination. So keep those records and check stubs.

This exercise only applies if you live in the house for less than 2 years. After that time period, you can profit up to \$500,000 (for joint filers) with no capital gains tax.

"My husband and I are having a discrepancy regarding the parking of vehicles in the street overnight. I say that the rule of "no parking cars in the street overnight' applies to inoperable vehicles only, and he seems to think that no vehicles whatsoever are permitted to park in the street overnight. Can you clarify this for

Editor's reply: We checked with Deputy Maurer of our Community Substation, who indicates, "There is no County Ordinance or State Statute prohibiting overnight parking on streets in communities. However, parking a disabled vehicle on the roadway is prohibited and vehicles in violation may be towed. In addition, it is illegal to bark an unregistered vehicle (including one with an expired tag) on the road at any time." BHA President Ted Grable adds. "You may wish to review the deed restrictions for your section to see if there are any parking confines mentioned. However, deed restrictions apply only to private property. Since the streets are public property, it may be difficult to enforce any such restrictions."

Developer files 3rd rezoning request; Residents examine proposal, voice concerns

A Gazette Report

Tampa developer Dimitri Artzibushev recently filed the latest of a series of applications intending to rezone 71 rural acres in the Bloomingdale area. The pastureland is located on John Moore Road just south of Wooddale Drive, one mile south of Bloomingdale Avenue. Homeowners in the area are concerned about the compatibility of the proposed single-family home subdivision and about preserving the rural character of their neighborhood. Residents have also expressed concerns about how the proposed design would further impact existing drainage and traffic conditions on Bloomingfield Drive.

United Neighbors, Dedicated Opposition (UNDO) is a group of residents representing numerous area communities, including Bloomingdale, whose mission

according to UNDO core team member Jeannette Figari is, "to work in cooperation with county officials and developers in promoting the responsible growth of the Brandon area." UNDO members have twice successfully presented their concerns with Artzibushev's previous rezoning requests to County Commissioners. UNDO members are at this writing reviewing the developer's new proposal. The application is tentatively scheduled to go before the zoning hearing master on November 29* at 6:00 pm, in the BOCC Board Room (City Center 2nd floor, 601 E. Kennedy Blvd., land marked as "the pink building".)

Figari says, "It is imperative that any residents who have comments or concerns regarding this rezoning request voice their opinions to the county's Planning and Growth Management Department at or prior to the November 29 meeting." Only those comments received and classified as a matter of public record on or before the November 29* hearing will be considered admissible at the final County Commission hearing on January 11*, 2000.



STD examines potential Iloomingdale reclaimed water system

The Bloomingdale Special Taxing District has begun formulating a "5-Year Plan", outlining several proposed projects designed to put our tax dollars to work in improving and beautifying our community. The proposed Reclaimed Water project is currently under evaluation by STD representatives in cooperation with the Hillsborough County Water Department. Following are some frequently asked questions about the reclaimed water process.

What is reclaimed water?

The reclaimed water process permits the utilization of effluent water; wastewater that is channeled from the sewer system to water treatment plants. Effluent water is normally cleaned and treated and returned to creeks, streams lakes and rivers. The reclaimed water process reroutes the cleaned, treated water to businesses and communities for irrigation purposes.

Is it safe?

Hillsborough County employs strict quality stanuards and safety procedures in the wastewater treatment process. Reclaimed water is intended for the irrigation of lawns and ornamental landscaping and for use in fountains or decorative ponds. It does NOT meet standards for drinking, bathing including swimming pools and outdoor showers, edible crop irrigation or washing cars, boats and outdoor furniture.

What are the benefits?

Every gallon of reclaimed water that is used for irrigation conserves a gallon of fresh drinking water. The use of reclaimed water for irrigation purposes would increase the amount of potable water available to the Bloomingdale area. The phosphorous and nitrogen contained in treated wastewater act as safe, efficient fertilizers for lawns and most plants.

Are there restrictions for reclaimed water usage?

Reclaimed water is exempt from county watering restrictions. It should be noted however, that the supply and available pressure might at times be interrupted due to a fluctuating water table and varying water quality. Reclaimed water is constantly monitored and will not be distributed for public use if the water quality drops below acceptable standards.

reclaimed water currently being used in our community?

Yes. Alafia Elementary School and Bloomingdale Golfers Club currently employ reclaimed water irrigation systems. Hillsborough County has included

Bloomingdale High School in plans currently in the design phase to bring reclaimed water to three area high schools using Community Investment Tax funds.

How are our common areas currently irrigated?

The STD maintains over 20 wells in Bloomingdale East and West providing irrigation at our parks, entrances and along our common walks. The STD reports the well system to operate sufficiently, citing however recent concerns about possibly dropping water tables and the increased iron deposits in the water. The well water's iron content is the culprit responsible for the rust stains on some of our perimeter walls. The STD is exploring the logistics, costs, pros and cons of utilizing reclaimed water to irrigate our common areas.

How could reclaimed water be brought into Bloomingdale?

STD representatives are currently working with Hillsborough County officials to theoretically outline the logistics of such a project, from feasibility to required pipe widths and possible underground routes.

How is the reclaimed water delivered to residences?

The water can be connected to in-ground sprinkler systems. For those residents without sprinkler systems, hoses with special fittings installed are permitted. Special fittings or low trajectory spray heads are required in order to reduce the aerosol drift of the water to eating, drinking and bathing areas.

What would the cost be to the residents?

STD representatives are working with County officials to determine two cost factors. The STD will seek a cost proposal to bring reclaimed water expressly to our common areas. A separate proposal to bring the water to both the common and residential areas of Bloomingdale will also be solicited. In either case, costs would be assigned to a long-term annual assessment applied to each resident's property tax bill. The county requires a 51% approval consensus of residents in any area requesting reclaimed water service.

Where do we go from here?

The STD will continue to explore the potential for bringing reclaimed water into our community. All residents are encouraged to submit their comments, concerns and questions about this proposed project by contacting the STD or attending the monthly Special Taxing District meetings. Meetings are held at the Community Office (3509 Bell Shoals Road behind SunTrust Bank) on the second Monday of each month at 7:00 pm. The STD voice mail number is 684-6667. 
