

BHA Meeting 18 October 1983



Bobby Stricklin spoke to the group present about the Bloomingdale Golfers Club--its construction, fees, etc. You are welcome to walk about the course but no vehicles please! If you want more information

about the Club, go by the office on Bell Shoals.

Chuck Loomis spoke on the revitalization of the Bloomingdale Mobile Watch. The Watch provides the extra eyes and ears to the residential neighborhood at least 3-4 nights a week to insure a safer, more secure community. The Watch has been reorganized and is building up a new staff of volunteers to ride in pairs in CB equipped cars (you provide the car and they provide the CB). Male and female volunteers are both welcome. In the past when a similar program was active the incidents of theft and vandalism were minimal. Members of Mobile Watch are also trying to help organize the Neighborhood Watch which can only be set up by the Sheriff's Dept. and has strict requirements to be met before a neighborhood quali-This program is federally funded and is nationwide. Volunteers are needed to be block captains -- which means you are the head of the telephone chain. Contact Joe Beatty 689-1099 for information.

Maryon Marsh stated that all was ready for the Halloween party and

that the Children's Christmas Party Committee is forming -- call her at

685-1843 with ideas and a willingness to help.

Narni Cahill said that Gazette printing costs are rising dramatically and ads cover about 1 of the cost and BHA's depleated bank acct. picks up the rest of the tab. The number of papers we have printed each month has doubled since last year yet membership in BHA has stayed about the same. If we don't have a larger BHA membership base to provide funding then the new Board is going to have to either give the paper only to BHA members...or find additional funding in more/higher priced ads...cr cease printing altogether...or some other solution...Think Readers!!!!

New Business: The following motions were made and carried: \$50 to Mobile watch for rental of Civic Center in effort to establish the Neighborhood Watch Program. \$45 for flyer announcing the above meeting and reminding of the BHA Halloween Party. \$250 towards the

Children's Xmas Party. \$50 to Mobile Watch for supplies.

Frank DeVito said that if you are having bad problems with mosquitos, call 870-0550-weekly if necessary-until they come out and spray.

Bob Knott, President announced the following: There is no change in the documents of Master Community Homeowners Assoc. as they are still at FHA and Criterion opted not to comment on the Assoc. until FHA is done with the papers. Bobby Stricklin is willing to chair a meeting after the documents come out for questions, The Assoc. will be put into effect at the soonest possible date. A homeowner suggested to Criterion that the 2 Board jobs not be offered to Bob Knott and Don Luke but instead ask for resumes from homeowners interested in being on the Board. Don has already handed in his resignation to the BHA Board and Bob made available to anyone interested copies of a letter from Don with his answers to questions of some Board members.

When asked if an STD was still possible Bob said "yes" and Branda Manning (681-2424) offered to head up a committeeto organize the effort.

Bob Knott offered to resign as President if members present felt that the Criterion offer had rendered him ineffective due to credibility, etc. He also siad that he has decided not to accept Criterion's offer and willpush energetically for an STD. Les and his wife, Krystyna, have 2 children, Krista 10 and Marc 8. He is in the Army and assigned to MacDill. "As a candidate for the BHA board, I believe BHA is the only organization which the residents can protect the future of Bloomingdale. How can we expect a homeowner's association controlled by executives responsible to the developer to do any better than the corporation itself. People who could care less about us make the decisions. Consider the legislator whose feathers were ruffled and refused to support his constituents only because we did not follow protocol. Or consider the school board who rejected reasoned argument that they were only moving the overcrowding problem to another building as they transferred the children of Bloomingdale West. Where is "Bloomingdale Elementary" with houses springing up like wheat in Kansas? We need a louder voice in the county. Through the BHA, we must determine the community's long range goals and then work to achieve these goals. I believe these goals encompass much more than the maintenance of common grounds."

I'd like to start this month's column by talking to you about landscape companies and the different services they have to offer. Some may offer only plant installation, others only landscape designs, still others offer a complete line of service. A complete line of services would include design, sprinkler systems, landscape construction (gazebos, berms, etc.), plant installation and followup service. Some firms have landscape architects, some have experienced plant people with drafting capabilities. Many retail nurseries offer landscape services and here you have the advantage of a wide selection of plants from which to chose.

A lot of people have the idea that landscape services are only for the wealthy. Even people on a budget can afford professional assistance at some level. Many landscapers, myself included, will do work in stages to spread out the cost or leave some phases of the job to the homeowner. If you have landscape needs and want professional assistance, the best approach is to:

1. set your goals (look at landscapes & decide what you like)

2. decide what you can afford

3. talk to some companies (many give free estimates) Remember, your landscape dollar is an important investment, both in the immediate pleasure you derive and in the future value of your home if you should wish to relocate. Keeping this in mind, make certain that the company or individual you work with is capable and responsible, and make certain they have a firm idea

of what you want.

Next, I'd like to breach a favorite subject of mine: native Florida plants in the residential landscape. This area of plants has long been ignored by the public and the professionals concerned. There are many beautiful native plants which are adaptable to the suburban landscape and which are recently becoming more available in the wholesale nurseries. Generally speaking, outside of oaks and other trees, retail nurseries have little to offer in this area. In the next few columms I will introduce you to a few of these plants and try to pass on the names of people and organizations who can assist you further.



Volunteers needed to help

Can you spare 3-4 hours every 4-5 weeks to make your home a safer place to live? If yes, the Mobile Watch needs your help.

What's a Mobile Watch?

The Bloomingdale Mobile Watch is an organization which promotes community safety and security because your friends and neighbors volunteer their time to extend the "eyes and ears" of the emergency services (Fire Dept., Ambulance/Rescue Squad & Sheriff's Dept.). Members of this volunteer group are residents of Bloomingdale--East, West, Suarez, Estates, etc. They're property owners and adult family members who want to keep Bloomingdale a good, safe place to live.

Why do we need one?

We all feel a little more secure knowing help is available when needed. Because the Mobile Watch has established good working relationships with the local emergency services, these services respond quickly and get directly to the area where help is needed. They know when the Watch calls them, it's for a good reason.

How does it work?

Volunteers are scheduled by the core committee to provide watch coverage on a night which is mutually acceptable. Currently, the Mobile Watch is active several nights each week, with seven nights/week coverage our goal. We have two cars out, each equipped with a spotlight and CB radio, and clearly marked with magnetic door signs. We like to have two volunteers in each car who drive through the neighborhood for 3-4 hours. The teams are in contact with a base station volunteer who phones the appropriate emergency service if needed. The Mobile Watch rules are simple: use your eyes, ears, common sense and the radio.

How do I volunteer?

Obviously, the effectiveness of the Mobile Watch is directly related to the number of people who'll give some time to insure the quality of their neighborhood remains top notch. Clip and use the form included and join us--there are no dues, fees or homeowners assoc. membership requirements (although most volunteers belong to BHA, the Mobile Watch is independent of any homeowners assoc.). Return the form to one of the core committee members or bring it to the next BHA meeting. If you'd like more information, give one of us a call. Thanks.



Dear Bloomingdale Residents:

Vell, it looks like BHA has added another "annual" to their list of rojects. This year inaugurates the second annual quest for a Special Taxing District (STD). Last year's effort was not accepted by the county legislative delegation for presentation before the state legislature. The primary reason it was not accepted was that there was a general lack of support from the Bloomingdale residents. I believe the most important reason for lack of support was a general confusion over why we need an STD, when we need an STD and an unbiased forum on the pros and cone of the issue. In what way would the STD benefit a community that is still less than 25% complete, when the developer and all the builders have more to gain from continued maintenance of common grounds and exterior walls? What effect, if any, does the sewage hook-up moratorium have on the further development of Bloomingdale? Will there be fewer homes built or a building lag until the sewage handling conditions improve? How do these and other factors affect our need for an STD?

Communication was a problem during the first STD attempt. Too much emotion, confusion between fact and fiction, a problem of what they don't know won't hurt them. Over seven months have passed since the county legislative delegation denied one of the most crucial steps in achieving an STD. Since that time Criterion has introduced their own mandatory community association for all new homes, that is awaiting various stages of approval. One catch, all existing homes would not be allowed to join. BHA commissioned a lawyer to help improve the Criterion plan. One of his statements in the "Gazette" indicated that a master homeowners community association had advantages over an STD.

BHA spent over \$1,200 to provide that information, money that could have been used to better educate the community on the problems facing a large suburban housing unit and what its future needs will be. Money that could have been used to have a general meeting with the builders who want to maximize their earnings from our development and who could suffer losses if our communities' outward appearance has that downtrodden look.

Have all the alternatives been explored? Does the BHA represent the whole community, a portion of the community, or the developer? Has there been so much change over the last seven months that we need an STD? Would someone please explain to me, unemotionally, of course, what the actual pros and cons are for a master community association vs an TD vs builder/developer acceptance of responsibilities?

Last week's Tampa Tribune carried an article about rajuvenation of the STD issue. Will there be an attempt to provide answers to the above questions? Will there be an improvement in the methods and means of communicating the issues to the community? Or will the short time frame between now and January, when the legislative delegation meets, be used to once again evaluate this issue on an emtional rather than a logical, informed level? This time, let's work together for the present and

future betterment of Bloomingdale.

Since we all live with neighbors close by there are bound to be times when we are irritated by "nuisances" -- be it your neighbor's car, cat, kids, dog, stereo, saw, etc. Most people when irritated complain first to their spouse -- then to another neighbor -- possibly spending mental time thinking of devious plans of retribution. . The end result being that they either 1.) never tell the "nuisance" what is wrong (only the rest of the development) or 2.) they have spent so much time rehearsing grievances in their mind that when they do speak to the "nuisance; it is with an anger/ retaliation that often far exceeds the original "crime".

Please, let's try to assume that our neighbors are people of character-assume that they are not aware that their cat, kids, dog, electric sander, car repair shop in the driveway, etc. are offending anyone! Let them know with a non-judgemental verbal or written notice: "You probably aren't aware that your dog has been in my flowerbeds and is driving me crazy" is preferable to "You are the most irresponsible #@*% people I've ever had the misfortune to call neighbors." Save the second version for later, if necessary but give your neighbors the benefit of a doubt the first time you let them know. Even if you have been annoyed 10 times, remember they don't know it until you say something.




