



Pool and Deck Resurfacing

tained. Cracked. Pitted. Dated. If, when asked to describe your swimming pool interior or pool deck surface these are the first adjectives that come to mind, it may be time to consider pool and/or deck resurfacing. Area companies offer a wide variety of resurfacing options ranging from basic and economical to custom, state of the art applications.


River Rock decks, a popular look in the 70's and 80's, are commonly being replaced with today's more modern, functional and easier to care for mediums. Most River Rock decks still around today were installed over 10 years ago and are very likely showing their age. Unless a persistent schedule of annual pressure cleaning and re-sealing has been followed, the decks lose their sheen and uniform coloring and the rocks tends to loosen and detach in fragments. River Rock can be patched and resealed, or the product can be removed entirely and resurfaced with one of several mediums available. Removal of River Rock is a costly (average \$3.00 per square foot) and messy procedure, but the results can be well worth it. Virtually any type of existing deck can be restored to a like-new appearance.

A very popular deck material in the past decade has been Kool-Deck, a sand and cement mixture that is hand troweled over the deck surface, producing a cool to the touch matte-look surface with varying degrees of texture, depending on the applicator's hand. This material is most commonly available in a "yellow buff" color, but some companies offer a choice of a few other neutral shades. Kool-Deck can easily be hosed clean with a soapy water and bleach solution, and can be acid washed if necessary. Although this type of deck does tend to develop hairline cracks and mildew can form in the characteristic "nooks and crannies", the product can be sealed with a penetrating water based clear sealer to prevent potential problems. Kool-Deck application costs typically range from \$1.75 to \$2.50 per square foot.

Acrylic decks, both true (acrylic mixed with granular quartz aggregate) and modified (acrylic mixed with concrete) have gained in popularity in the 90's. Area pool companies agree that acrylic is less likely than Kool-Deck to de-laminate from the concrete subsurface and break up due to penetration of moisture. A typical rolled-down resurfacing job (with modified acrylic) averages about \$1.50 per square

foot. This method produces a random stipple or "sandy" surface, can be done in a number of premixed colors and usually offers a 10-year warranty. Although acrylic decking of any type is less likely than unsealed Kool-Deck to develop stains, cracks and harbor mildew it must be periodically resealed, ideally on an annual basis.

One area deck resurfacing company we spoke

with, Bosmeny and Associates, Inc., offers custom, one of a kind true acrylic application. The product offered by Bosmeny is presented as mildew, algae, chip and flake resistant and is said to stay flexible. Owner Steve Bosmeny explains the "custom" aspect of his product applications, "We use stencil patterns to produce various looks such as natural stone, traditional brick and herringbone designs in virtually any color desired. After prepping the surface we hand trowel the base coat. Following a 24-hour curing period we spray a pattern onto our special stencils or we can hand mask a custom design and trowel the topcoat on. The pattern spray or top coat is raised 1/16 to 1/18 of an inch above the base coat line, which in a "brick" finish appears to be the grout." Custom acrylic applications costs range from \$2.00 to \$5.00 per square foot.

While a visual inspection can usually indicate whether or not a deck needs to be resurfaced, swimming pool interiors can be trickier. Before we take the plunge into completely resurfacing our pools, there are some preliminary things we can try to save a little time... and a lot of money. Integrity Pools Service Manager Rick Glover explains, "First, call a professional. We may be able to chemically treat the staining or discoloration problems in the pool. The is no magic cure in a bottle," says Glover, "but there are several stain lifting and metal removing products that we can try first." A light acid washing, done by a

professional, can greatly improve the appearance of the pool. However, Glover cautions, "Homeowners nould never attempt to drain and acid wash their pools themselves." Aside from the obvious chemical dangers, there is this to consider, "Your in-ground pool is like a big concrete boat," he says. "If you drain it, depending on the level of ground water below it, it will float!" In other words, unless a professional pumping system is used and the pool is constantly monitored during the draining and washing process, the concrete will actually lift up from the ground (probably in huge chunks) and destroy the entire pool. Yikes.

Several products can be used to resurface pool interiors. The most commonly used material is plaster, also referred to as marcite or whitecoat. Marcite is composed of marble sand and white cement. It is a hand troweled product and should last from 10 – 15 years with proper maintenance. Dye can be added to the mixture to produce different colors. Marcite usually carries a 1-year warranty. The average cost for resurfacing a 15' x 30' pool with marcite is about \$2,200.

Quartz finishes are growing in popularity with new pool buyers in the past 5 years and homeowners have begun requesting the cement and quartz ock mixture for resurfacing jobs. Quartz comes in many colors and produces a speckled finish. The material typically carries a 5-year warranty, with an average cost of approximately \$3,000 for a 15' x 30' pool.


Exposed aggregate is a mixture of cement and tumbled (sharp edges smoothed) rocks, slightly larger than quartz. After application, the pool interior is

acid washed to expose the rock surface, resulting in a pebbly finish. Exposed aggregate applications typically carry a 5-year warranty and are the most expensive of finishes available, typically averaging \$3,800 for a 15' x 30' pool.

There are many choices of materials and even more choices of contractors to do the job. It is recommended that homeowners call the local Chamber of Commerce, Pool and Spa Institute and Better Business Bureau to insure the good standing of prospective contractors, get at least 3 estimates and ask friends and neighbors for referrals. As Integrity's Rick

Glover says, "We all have quality materials available to us, so it's really a matter of who the person doing

the work

is," he says. "Whether it's your car mechanic, a roofer or a pool contractor, my advice is to try to determine if the person doing the work is experienced, cares about the outcome and has a sense of personal pride in his work. The finished product will only be as good as the workmanship."

Restaurant Review

ince I highlighted a Mexican restaurant in August (even though the buffet was decidedly non-Mexican), I had some reservations about returning to another Mexican restaurant. But at the urging of Fred Uphoff, a long-time Bloomingdale resident and friend, I went to Estela's

Mexican Restaurant on a recent Saturday afternoon. This was another one of Fred's excellent suggestions that I've listened to over the years. There is no doubt that this is an authentic South of the Border cantina. You get that feeling from all the Cervaza banners on the outside and the continuous Mexican music inside.

This is Estela's second restaurant. The original is on Davis Blvd. on Davis Island. It really is one heck of a fun dining experience and will be even better after the staff has a chance to settle in and iron out the inevitable initial kinks. We were seated quickly and waited patiently for our busy server to take our beverage order. The iced teas were fresh brewed, a real plus these days. The complimentary tostida chips were served promptly along with a dish of salsa and a cruet of additional salsa. The chips were different; thick in texture and very mild in taste. The salsa was excellent; I'd say a definite 2 alarm, so be careful when you first try it. For comparison, we'd say the majority of Mexican chains serve 1 alarm salsa.

The menu caused my wife and I to do a double take. It is the most extensive Mexican menu we've seen in years. There are no less than 14 appetizers to choose from! How about Mexican Chicken Egg Rolls (seasoned chicken breast, frijoles, corn and cheese wrapped in a flour tortilla, deep fried and served on a bed of lettuce and chopped tomatoes) served with Estela's special guacamole dip for only \$4.50, or the Fresh Cerviche (marinated shrimp, tomato, onions and cilantro) for \$6.00. Remember, it will take you some time to read the entire menu and you may still be bewildered! While we studied the menu we ordered a cheese dip appetizer, a combination of melted mozzarella, Monterey Jack and Mexican cheese. It had jalapenos and probably reached a one on the alarm scale.

The combinations are numbered 1 to 25, with a tremendous array of tacos, enchiladas, chile rellenos, tostados, burritos, chalupas or chile con queso. I chose the number 1, one taco (I selected beef), 2 enchiladas and Spanish rice, for \$6.50 (the most expensive combination plate is only \$7.00). My meal, with the white jalapeno cheese enchiladas, was

My wife ordered from the flip side of the menu, where you will find 19 specialty items that include Estela's Especial Dinner (chalupa with guacamole salad.

one chile relleno, one beef taco, one enchilada and one tamale with Spanish rice and refried beans) for \$9.00 and the Chili Colorado (rib eye steak chunks with a red chili sauce, served with rice, beans and flour tortillas) for \$8.50. My wife selected the Steak Burrito (chopped rib eye or chicken chunks wrapped in a large flour tortilla), served with spicy white cheese, rice and guacamole salad for only \$6.95. The rib eye was spiced just right and was quite tender. Onions and green peppers made a surprise appearance in the burrito (onions and my wife don't get along), so I would suggest asking your server to list all the

ingredients in your order to avoid such a surprise.

They have an extensive children's menu and the staff was very attentive to the youngest diners. The desserts include homemade flan, Grande Sopapillo and "Choco Taco." Although we didn't try that one, it sure sounded interesting; bananas and cream

wrapped in a flour tortilla, deep-fried, covered with chocolate and served with vanilla ice cream. If you try a Choco Taco, drop me a line and let me know how you liked it. Our bill was \$23 for beverages, appetizer, entrees, tax and tip, but you can eat well for less. The most expensive item on the menu is the Combo Grande Fajitas for only \$11.95. We will cer-

tainly return south of the border again to sample more of Estela's extensive offerings. Until we eat again,



County does NOT endorse curbside house number painting

any Bloomingdale residents have been approached by solicitors offering to paint house numbers on the curb in front of their homes. These solicitors often advertise by illegally placing flyers on mailboxes, and have been known to claim that the painted numbers "meet code requirements" and "are needed to help emergency personnel locate street addresses."

According to Hillsborough County Roads and Streets officials and a representative from the County 911 Department, these numbers do NOT meet Hillsborough County's 911ordinance for identifying house numbers and are NOT endorsed by the county. Officials also point out that the paint wears out over a short period of time, rendering this method of address identification useless.

The county ordinance requires placing "clearly visible numbers and/or letters on the dwelling in a location clearly visible from the street." Placing numbers on both sides of a mailbox, if it is located in front of the dwelling, is acceptable. Officials suggest that both the home and the mailbox numbering methods be used in order to provide maximum assistance to emergency personnel searching for a particular home.





In contrast to this glaring lack of understanding of the dista- ease, 78 percent of those with peripheral neuropathy said it had a substantial impact on their ability to enjoy a normal life, and 61 percent said it affected their ability to do their job.



- 1. Irrigation: Brandon Irrigation replaced a broken 2" valve and repaired a broken 3" main line in the Rosemead system, located all 7 valves in the Cambridge Cove system, repaired valve 6, replaced the timer and repaired a valve in zone 1 in the Greenhollow system. DPMI inspected the 8.5 miles of irrigation, repaired 34 spray heads, replaced 9 rotors and 2 solenoids and adjusted or repaired 19 risers.
- 2. Landscaping: The STD assumed maintenance responsibility as of July 1 for the Heritage Park area which includes a well, 9 zones and 313 spray heads of irrigation, 39,462 square feet of St. Augustine grass, an entrance way and 2,520 feet of wall with Creeping Fig. DPMI conducted the pre-bid meeting for the fertilization contract for next year; four contractors were present for the meeting. DPMI measured the remaining areas on Canoga Park,

Garnet and Glenhaven to be plugged with St. Augustine grass.

- 3. Other: ZK construction repaired the damaged wall on Erindale and Warmsprings and will repair another damaged wall down the road in the near future. DPMI painted all the school bus benches and some walls on Erindale, Culbreath and Shady Nook. DPMI measured the walls on Natures Way and Culbreath and identified the brick entranceways that need to be cleaned. Phoenix painting completed the wall painting on Bell shoals and Natures Way. There were 57 individual sections of wall to be painted on the inside; 23 homeowners either refused or did not respond to our request for a free wall painting. DPMI replaced 8 lights and 1 light receptacle.
- 4. In the land of eat, drink and pitch out the window, DPMI picked up 30 bags of litter, 2 hubcaps, a hair curler, a bike kickstand, a motor mount, a stadium blanket, 2 plastic squirt guns, a tire, 3 towels, a wash cloth, a shoe, 3 socks, a scissors, a red wine glass and \$.26 cents. The beverages of choice were Budweiser for beer, Coke for soft drinks and, vo-hoho, Captain Morgan spiced Rum for alcohol. ®



A Bloomingdale West resident writes (via E-mail): "I recently had outgoing mail stolen from my mailbox. I put it out on my way to work and fortunately my wife discovered it was missing several hours before our normal mail pick up. After contacting both the Post Office and the Hillsborough County Sheriff's Department, I stopped payment on the checks that were destined for utilities companies. Several days later, the bank reported one of the checks was forged and cashed for an amount twice as much as it was originally written. The second check was shortly thereafter also presented for payment. I offer this information as a warning to other residents; I suspect that I am not the only victim of this type of mail theft. Now I will use public mailboxes when I have outgoing bills with checks."

Editor's reply: We forwarded your letter to Deputy Pete Maurer of the Bloomingdale Community Sheriff's Substation, who informs us that both the Sheriff's Office and the Post Office are investigating recent area mail theft incidents. Deputy Maurer supports your suggestion about using Post Office mailboxes for outgoing mail containing checks and has circulated this advice through the Substation and Community Council members. Thank you for bringing this matter to our attention.

A Bloomingdale West resident writes (via E-mail): "As a recreational cyclist I enjoy using Bloomingdale's bike lanes. They make for safe riding without having to use the sidewalks and roadside shoulders. I have noticed that a number of families (especially along Bloomingfield) routinely park their cars in the bike lanes. Aren't there rules against this? Just curious."

Editor's reply: Deputy Pete Maurer of our Community Substation refers us to the following Florida Statute 316.1945 titled "Stopping, standing or parking prohibited in specific places" which lists "on a bicycle path" among the prohibited areas. Deputy Maurer indicates that our County Ordinance 98-48 is worded the same, and could result in a Deputy or Parking Enforcement Specialist issuing a County parking cita tion in the amount of \$30.00. Deputy Maurer says, "We will begin to advise homeowners in the area and post warning tags on the vehicles."




Judie Tiso, The Greens -
